STANDARD RATE SCHEDULE: Green Power Adder

---

DEFINITIONS

Green Power: Electric power and energy generated by clean, renewable resources such as wind, solar, biomass (energy from trees and plants), geothermal, and low-impact hydro. Additionally, electricity generated by burning methane gas produced by landfills is considered Green Power because it is better for the environment to burn the methane rather than releasing it into the atmosphere.

Adder: The cost to the member *above* their current rate for electric service.

Green Power Block: Green Power shall be reserved and available in established segments of kilowatt-hours to be determined annually based on availability.

AVAILABILITY

Available to all members for all uses subject to the Terms and Conditions of Service established by the Cooperative. The ability to participate in this adder will be subject to the offering of Green Power by wholesale power suppliers with whom the Cooperative has a contract for service. Any time Green Power is not available from the above-described, wholesale power suppliers, this adder will not be available to the membership.

A limited quantity of Green Power is available and will be offered on a first-come, first-served basis. Participation is for a full calendar year and is on a take-or-pay system, meaning if a member agrees to participate, they will be charged the adder monthly for the full year. If a participating member discontinues electric service with the cooperative before the end of the calendar year, the total remaining adder shall be applied to their final bill.

MINIMUM AND MAXIMUM PARTICIPATION

In order to make the opportunity to purchase Green Power available to as many members as possible, member participation may require a minimum and be limited to a maximum number of Green Power Blocks as detailed in the Member Agreement to Participate in the Purchase of Green Power.

ADJUSTMENTS TO BILLING

Taxes: The amount calculated at the above rates is subject to adjustment by the tax rates required by law.

MEMBER AGREEMENT

To participate in the Green Power Adder, each member must enter into the Member Agreement to Participate in the Purchase of Green Power. The term of the initial agreement shall extend one (1) year from when Green Power becomes available and shall automatically extend until ninety days notice of intent to terminate participation is provided by either party. The agreement may be modified annually to establish the number of kilowatt-hours per block and the adder of the wholesale power suppliers.
